<u>INTERMENTS</u>

The fees indicated for the various heads of items 1 and 2 include the digging of the grave.

- (2) For any interment in a grave in respect of which an exclusive right of burial has been granted.
 - (i) of the body of a child whose age at the time of death did not exceed one year
 - (ii) of the body of a child whose age at the time of death exceeded **Nil** one year but did not exceed 16 years.
 - (iii) Of the body of a person whose age at the time of death exceeded 16 years £250.00
- (3) For the interment of cremated remains in a grave in respect of which an exclusive right of burial has been granted.
 - (i) of a still-born child or a child whose age at time of death did not exceed 1 year
 - (ii) or of a child whose age at the time of death did not exceed 16 years.
 - (iii) of a person whose age at the time of death exceeded £80.00 16 years
 - (iv) for the scattering of cremated remains on top of a grave No charge
