For the right to erect or place on a grave on which an exclusive right of burial has been granted.

(i)	a small cross of wood	£23.00
(ii)	a headstone not exceeding one metre in height	£170.00
(iii)	an inscribed vase in the form of a monument	£100.00
(iv)	a memorial plaque/vase on ashes plot *	£130.00

All plaques must be black granite 12 x 12 x 2 (inches), to be fitted flat to the ground with an optional black polished top sunken vase 6 x 6 x 4 (inches).
